Agenda Items:

ED Report – Rob B:

- We have registered 665 clubs for 2012, well ahead of last years pace. Our club development coordinators are making calls and outreach to all club contacts. Our 2012 Rule Book is in the final proof stage and will be mailed with the 2012 club welcome kits the 2nd week of December.
- Last year at this same time, we had renewed 12,905 members. As of today, we have renewed 14,307 members.
- Nadine has set all our committee appointments and the committees are operating at full steam. As an example of committee momentum, the Coaches Committee has selected seven coaches who will be writing online workouts as a member benefit. The workouts target the various segments of our membership such as beginner, stroke, open water, high intensity/speed, high volume, triathlon and expectant mothers. The seven coaches and their biographies are being promoted with a full-page ad in the January/February issue of *SWIMMER* magazine.
- We have completed the makeover of *SWIMMER* magazine. The last magazine redesign was 2005 and this redesign will modernize *SWIMMER* with more white space, new graphics, and a few new features. The January/February issue will be shipped the 2nd week of December for on time delivery the first week of January.
- We have 21 sponsors renewed and a title sponsor for the 2012 Summer Nationals, we have exceeded our budgeted sponsorship revenue budget. The office renovation project is anticipated to be complete by years end. The search process for our Club and Coach Services Director is progressing as planned.

Presidents Report – Nadine Day:

The History and Archives committee is working putting together a presentation.
