## Minutes

Great Lakes Zone Chairperson C.J. Rushman called the meeting to order at 8:05 p.m. EDT.

- Zone Championship: Lisa Brown made a request on behalf of Indy Aquatic Masters to have the Chris Clark Invitational serve as the Great Lakes Short Course Zone short-course meters championship in 2017 to be held 9/30 6 10/1 @ IUPUI Natatorium. The event will include 800, 1500 and relays. C.J. Rushman asked if the intent was for this to become an annual event or a one-year event. Lisa confirmed it is intended to be an annual event.
