- 1. OW Sanctions Guidelines- No one reported any further questions about the new guidelines.
- 2. Grant Relief Program Susan reported the 6 applications have been received and 4 approved. Please continue to promote the program.
- 3. Status to 10 mile OW NC event in Minnesota they will be unable to host this event this year because of sanction fee costs associated with other events held in conjunction with the 10 mile.
- 4. 2014 & 2015 Bid winners and process Donn discussed changing the timing of this process to await convention actions. After discussion, the committee decided the process will continue on schedule for this year. Donn will send out the draft letter and bid form to the working group for review and editing. He will then send out the final document.
- 5. Change in NC event per swimmer surcharge Donn suggested a surcharge increase and gave an example of financial consequences if the surcharged was increased from \$1 to \$3 for the postal events and \$3 to \$6 for the NC championships. Susan Kirk asked for information about the benefits that National Championships receive from headquarters and Nadine indicated she would forward that information. The committee will continue to discuss this issue via email for a decision next month.
- 6. Working groups reports
  - a. Rules/Legislation Lynn Hazelwood reviewed the Legislative proposals which were sent out to everyone on the committee. These should be further reviewed by the committee before next month's meeting.
  - b. PARA (Patches, All-Americans, Records, All-Stars) Tom reported. We have posted our 2013 timeline on Google Drive. We are current to the timeline. OHP results have been received. Spreadsheets have been updated. AA results are due next from the >3/<6 Mile OW Championship by 6/1/13. Jill reported that all records are updated on the website. A new spreadsheet on Google docs need to be set up for this year's records.
