- c. Club Assistant Colleen & Phyllis did not submit a report
- d. **Safety** Bill Roach reported 50 open water events have been sanctioned so far this season. This time last year, there were 53 event sanctioned.

One event was cancelled because heavy rains contaminated the water, and 3 events are currently pending. Three National Championships have been held with a USMS Independent Safety Monitor present. Their reports about the safety of the events have been very positive. Seven events have filed a Thermal Plan with their sanction application. The Thermal Plan has been well received, and Bill feels cold-water events will be prepared to handle cold water emergencies.

The new Open Water Safety Plan Application form, required in 2016, has been used by several events requesting sanction. New event directors find the document much easier to use. The document asks questions and requires answers concerning safety procedures that need to be addressed in every open water event.

- e. **Documents** James reported that he is waiting on word from Jim Matysek who is looking into using the Club Assistant Final Results directly for USMS website posting. If this is possible, then a major revision to the championship package will be done that will be more user-friendly for the hosts and liaisons.
