  - c. Reviewed final draft of proposed Free Trial program for use by USMS Clubs
    - i. Suggestion to add 30-Day Trial selection option on Registration Form if program becomes standardized.
- 4. Reviewed and discussed new governance structure path
  - a. Marketing functions are now being carried out by the National Office staff, making a standing committee of volunteers unnecessary.
  - b. USMS Planner expected to be replaced by a calendar insert in the USMS Swimmer magazine, Go The Distance participation and FLOGs
  - c. USMS members with subject matter expertise may become part of a volunteer pool from which the National Office can draw for specific projects.
  - d. New LMSC Development Committee
    - i. The LMSC Development Committee shall work to strengthen LMSC governance and operations by providing educational opportunities and mentoring for LMSC boards and officers. The committee shall identify and provide support for LMSCs experiencing operational and governance issues, and monitor compliance with LMSC minimum standards as defined by the Board of Directors.
    - ii. This committee has been added to reflect the need for an intentional standing committee created to address LMSC development, rather than this responsibility falling on the Zone Committee. This committee will also assume LMSC-related activities that were within the purview of the Communications and Marketing Committees.

#### 5. Roundtable

- a. Discussion of USMS support for a drop-in guideline that encourages Clubs to offer visitation opportunities as an expression of goodwill.
