 - a) Date: Saturday, March 24, 2018 from 6:00pm 10:00pm
 - b) Venue: Tentative hold on the Basking Ridge Country Club Ballroom confirmation must be made at 10/29 board meeting. Non-refundable \$500 cash deposit is required
 - c) About: The Basking Ridge Country Club banquet facility overlooks the fairways of the golf course and 260 private acres beyond, and has knee-to-ceiling windows offering a panoramic view. The Pennbrook Ballroom holds events of 75 200 guests with a gas fireplace and outdoor balcony. The minimum number of guests required for the ballroom is 75 adults.
 - d) Cocktail Hour & Buffett Dinner: The buffet dinner comes to \$49.53 per person, including service charge and NJ sales tax. Cocktail hour hors d'oeuvres (passed or self-serve option) are a separate price at \$12.00 per person in addition to the \$49.53 per person dinner
 - Passed hors d'oeuvres can select 8 from a list of each hot, cold, and delicate china spoon foods
 - Self-serve/Market Table includes an arrangement of NJ's best and local produces included: imported and domestic cheeses, grilled seasonal vegetables and heirloom salads
 - e) Cash Bar/Drinks: There is a \$125 bartender fee for the cash bar. Beer & wine selection requests can be made from the Delicious Heights menu. Soft drinks and unsweetened iced tea are included; lemonade is an extra cost
 - f) Set-up: 15 tables of 10 available; high tops available for cocktail hour; table for awards and prizes; optional dance floor
 - g) AV: Microphone (clarify was originally told mic is rented for \$50) and projection screen are complimentary, along with a table for the projector
 - h) Decor: White table cloths different color linens are available at an extra cost; napkins included (red/blue); can adjust lighting for NJ Masters colors (red/blue); NO center pieces provided/available, but can bring our own
 - i) Hotel: Can look into recommended hotels as a suggestion for guests Hyatt Regency Morristown, Westin Governor Morris of Morristown, Courtyard Marriott Basking Ridge
 - j) Rough Cost Estimate: $$49.43 + $12.00 = $61.53 \times 75 \text{ guests} = $4614.75 + $125 \text{ bartender} = $4739.75 (Dolce 2017 = $4161)$

- k) Attendee Cost Proposal/Recommendation: Increase initial and incremental attendee and coach cost by \$5. Keep attendance complimentary for award recipients
 - 2017 Members/Guests \$25 early, \$35 late and \$40 at the door; Coaches \$15
 - 2018 increase to \$30, \$40, and \$45; Coaches \$20
