# 6. Major Issue Facing LMSCs-Shortage of Officials to Staff Local USMS Meets

<u>Issue</u> is two-fold: #1-lack of sufficient officials to staff USMS meets, and #2-difficulty recruiting volunteers to become trained as officials.

<u>Background</u>: NC, AZ, CA, and WA are a few of the jurisdictions having difficulties staffing USMS meets. Some areas are also having trouble staffing high school and USA Swimming meets. In some areas, USA Swimming officials don't want to have to continue with all the requirements for USA Swimming recertification, so may be willing to work/recertify as USMS officials. Stipends for officials are paid in some places (~\$25-\$80/meet). Some LMSCs require official(s) to be identified on event sanction applications, and a sanction is not granted if the officials are not indicated. A key in some areas is to identify the officials early. Adjunct questions are: #1-do USMS officials need to be members of USMS, #2-will USMS officials certification cards be issued, and #3-who will be responsible for documenting the training/recertification/officiating of these USMS officials?

<u>Action</u>: MSP that task force #1 be formed to identify key issues and solutions relating to recruitment of officials, and task force #2 be formed to identify key issues and solutions relating to training/certification/ recertification of officials.

*Task force #1* [recruitment] will be comprised of **Brian Albright** (chair), Dave Diehl, Herb Schwab, Chris McGiffin, and Ed Saltzman.

*Task force #2* [training] will be comprised of **Michael Moore** (chair), Mary Pohlmann, Tom Cox, Alina Perez de Armas, Pat Baker, Chris McGiffin, and Ed Saltzman.

Kathy and other Rules Committee members will proof the written exams.

Ed will disseminate officials training information/documents that are currently in place.

The task forces hope to meet prior to the next conference call.
