The committee, with input from the Long Distance Committee, shall prepare guidelines pertaining to the management of USMS open water swimming for approval by the Board of Directors. The committee shall increase awareness about open water swimming and identify opportunities to promote USMS. The committee shall consist of the committee chair and sufficient members to execute the committee function. The Long DistanceCommittee chair shall be an ex officio member of the committee."
- Special Report from USMS CEO—Dawson Hughes. In Dawson's absence, Jay Eckert reported on the progress of the Open Water Task Force (authorized by the USMS Board of Directors at the 2018 Convention). Jay's outline is attached below.
- 3. Report from USMS Vice President—Donn Livoni. Donn reported that his role is that of a liaison between the OWC and BOD, and reminded us to work through the USMS committee structure.
- 4. Report from USMS Open Water Compliance Coordinator—David Miner. David was absent, but Bob relayed that there were 54 USMS-sanctioned events held and 2 sanctioned events canceled in 2018.

- 3. Rules & Legislation Subcommittee. Purpose: Working as a joint subcommittee with members from both OWC & LDC, examining & vetting rules proposals and bringing these proposals for consideration to the OWC then the LDC (although proposing rules to the USMS HOD is an LDC function, we have chosen in recent years to have this group work across both committees for thoroughness). You have one assignment for the next meeting...to review (and comment on as necessary) part 3 of the 2018 USMS rulebook, which will be available on the OWC Forum shortly. Chair: Bob Bruce. - 4. <u>Safety Education Subcommittee</u>. Purpose: To review any new or ongoing business to the OWC relating to safety, and to review the documents and process of safety planning with the Open Water Safety Advisor. Chair: Bob Kolonkowski. Members: Kim Elsbach, Rory Grigull, Jim Kennedy.
- 5. <u>Event Management Subcommittee</u>. - 8. Open Water Swim Training Subcommittee. Purpose: To develop guidelines and materials for coaches to prepare swimmers for open water swims. I hear that the Coaches Committee is considering adding such material to the Coaching Certification program, so we may have an opportunity to work jointly with this committee. Chair: Mark Johnston. Members: Denise Brown, Kim Elsbach, Jim Davidson, Helen Naylor.

Open Water Strategy Task Force

Notes for Open Water Committee call (Jan. 20, 2019)

The Open Water Task forced was created by the BOD at the 2019 Annual Meeting in Jacksonville. OWTF consists of BOD (Donn Livoni), OWC (Bob Bruce and Karen LeFebre), LDC (Ali Hall and Phyllis Quinn), and NO (Dawson Hughes and Jay Eckert).

So far, we've had several calls as a group and individually and contacted many stakeholders such as Event Directors to gather feedback.

Here are notes from a recent OWTF call for additional information:

- 1. Goal: Strategy to grow number of sanctioned open water swims and participation by 2024:
 - a. 100 sanctioned events
 - b. 25k splashes (estimated 13k now)
 - c. Key component of USMS membership growth strategy

2. Surveys and Initial Findings

a. Event Directors

- i. Streamlined sanction (including with USA-S) and financial process, reduced costs or cost savings (registration, caps/buoys, etc.)
- ii. 75% of event directors that do not currently sanctioned with USMS would sanction again if process simplified
- iii. 42% not satisfied with NO support
- iv. Top priorities to provide more flexibility and improve event:
 - 1. More streamlined dual sanctioning process with USA Swimming
 - 2. Streamline reporting/financial processes (one-events, sanction fees with LMSCs, etc.)
 - 3. OW events results database

b. OW/LDC/BOD

- i. Promote only sanctioned events via email and calendar of events
- ii. Streamlined sanctioning and financial process
- iii. Results database
- iv. Open Water / Triathlon Membership (not a specific question but mentioned in conversations and recommended by 2014 Task Force)

c. LSMCs

- i. Streamlined sanction (including with USA-S) and financial process, reduced costs or cost savings (registration, caps/buoys, etc.)
- ii. Results database
- iii. Anecdotal topics
 - 1. Mighty Mac Swim
 - 2. North Texas (Richard Garza)
- iv. Open Water / Triathlon Membership (not a specific question but mentioned in conversations and recommended by 2014 Task Force)

 - b. 2019 Goals Need buy in from committees, not necessarily a topic for HOD
 - i. Improved marketing of events through web articles and targeted digital marketing
 - ii. Build a Minimum Viable Product (MVP) Results Database
 - iii. Work to establish policy of promoting only USMS events through USMS channels
 - iv. Build USMS Sanction value and benefits document comparing our value with competitors
 - c. 2020 Goals may need HOD discussion budgets, legislation, rules, etc.
 - i. Streamlined sanction process that aligns (and possibly integrates) with information needed for event registration
 - ii. Rules philosophy discussion for LDC and OWC
 - 1. Needs more detail from data and specific areas for review
 - iii. Added Value for Event Director
 - 1. Possibility of offering reduced cost or free registration software
 - a. Simplified process
 - b. Provide integrated data points with registration, participation and results
 - c. Reduce event director expenses add value
 - iv. Consideration of OW Membership
 - 1. 2014 recommendation
 - 2. Standardized fee discussion
