- 2. Report from USMS Vice President—Donn Livoni. Donn shared general thoughts about the winter BOD meeting and the Open Water Task Force (particularly the surveys). He answered some questions

The measurement of this goal will be the quantity of events, swims, & splashes, the quality of those experiences, and other metrics that will help us measure our progress to accomplish these goals." Report: No proposals to update; this is the OWC goal for this year.

Discussion of the results of the USMS Open Water Task Force Surveys. See Development & Promotion Subcommittee notes

Subcommittee Reports:

- 1. Open Water Development & Promotion Subcommittee. Purpose: To generate real, actionable ways to develop and promote open water swimming. This is the central purpose in the committee definition. Chair & Members: Chair: Will Reeves. Members: Denise Brown, Lynn Hazlewood, Jim Kennedy, Karen LeFebre, Joe Linford. Report: We discussed the summary of the surveys sent by the National Office and received from the BOD, LMSC leadership, event directors, and open water swimmers at large. Common topics included the perceived high cost and difficult process of putting on events, the difficulty of obtaining dual-sanction events with USA-Swimming, swimwear rules, competition vs. partnering with other NGBs, and marketing.
- 2. <u>Open Water Guide to Operations (OWGTO) Subcommittee</u>. Purpose: To review, revise, format, and communicate the contents of the OWGTO. Chair: Bob Bruce. Members: Becky Cleavinger, Lynn Hazlewood, Eric Hekner. Report: None
- 3. Rules & Legislation Subcommittee. Purpose: Working as a joint subcommittee with members from both OWC & LDC, examining & vetting rules proposals and bringing these proposals for consideration to the OWC then the LDC (although proposing rules to the USMS HOD is an LDC function, we have chosen in recent years to have this group work across both committees for thoroughness). You have one assignment for the next meeting...to review (and comment on as necessary) part 3 of the 2018 USMS rulebook, which will be available on the OWC Forum shortly. Chair: Bob Bruce. Members: Becky Cleavinger, Lynn Hazlewood, Will Reeves. Report: Bob reported that—upon Patty Miller's recommendation—that the OWC will focus on development more than rules this year, only discussing the most substantive and/or controversial proposals.
- 4. <u>Safety Education Subcommittee</u>. Purpose: To review any new or ongoing business to the OWC relating to safety, and to review the documents and process of safety planning with the Open Water Safety Advisor. Chair: Bob Kolonkowski. Members: Kim Elsbach, Rory Grigull, Jim Kennedy, Peter Lee. Report: Nothing new to report
- 5. Event Management Subcommittee. Purpose: To prepare material for seamless presentation of events and to develop the training a course on event development & management for Event Hosts/Event Directors (first piloted in presentation in 2015). Chair: Karen LeFebre. Members: Jenny Hodges, Joe Linford, Helen Naylor. Report: Helen reported on the upcoming open water management clinic in Tennessee this spring.
- 6. Officials Subcommittee. Purpose: To evaluate current practices in officiating USMS open water events and to develop materials to improve this. Chair: TBD. Members: Rory Grigull, Peter Lee, Helen Naylor, Will Reeves. Also Jim Davidson from the LDC. Report: Bob reported that he is reconstructing some pertinent documents damaged in a computer crash and hopes that he can have them ready by the next meeting.
- 7. <u>Awards Subcommittee</u>. Purpose: To manage the process for selecting our annual Open Water Service Award, and perhaps exploring the honoring of USMS open water "pioneers". Chair: Jenny Hodges. Members: Bob Kolonkowski, Will Reeves. Report: Jenny Hodges agreed to chair this group.
- 8. <u>Open Water Swim Training Subcommittee</u>. Purpose: To develop guidelines and materials for coaches to prepare swimmers for open water swims. I hear that the Coaches Committee is considering adding such material to the Coaching Certification program, so we may have an opportunity to work jointly

with this committee. Chair: Mark Johnston. Members: Denise Brown, Kim Elsbach, Jim Davidson, Helen Naylor. Report: Mark Johnston reported plans to coordinate the subcommittee's work.
