Cheryl Wagner received the 2012 Colonies Zone Dorothy Donnelly award. Vice Chair (John Carlson) no report

Registrar (Jeff Roddin) Registrations down slightly from last year. 2012 - 2802 2011 - 2944 2010 - 2789 Starting with the 2013 registration year USMS is raising their portion of the transfer fee from \$1.50 to \$2.00 (PV portion has been \$3.50 to set the transfer fee at \$5). Approved - agreeing that PV will absorb the increase and reduce their portion to \$3. PV club page (PDF brochure) on website. Jeff keeps it current but does anybody use this anymore? A quick poll determined many in attendance didn't even know about it. Of the 52 LMSC's, PV is most dense in membership for their area. New team: FEXY (triathlon club).

Treasurer (Tim Timmons) 12 month period - treasury was \$4,000 to the good. 2 accounts - savings & checking - \$65,000. National USMS office progressively taking larger amount of registration fees. PV will review how much we need in reserve and whether dues should be increased.

Secretary (Cheryl Wagner) No report

Newsletter (Cheryl Wagner) \$3,000 in postal account. Would like to put meet photos up on PV website.

Coaches (Frank Marcinkowski) Working with Bill Brenner on ASCA Level III Training. Alexandria Masters is looking at dates to host training (suggestions: 2nd or 3rd weekend in May or September or early October). Pre-requisite of Level I & II, so may ask another club to host those. PV will pay half the cost of Level III training for interested PV coaches. PV paid \$755 last year for coaches training "scholarships". High performance camp in Greensboro sold out. Frank Marcinkowski taught some of the courses. 1/3 of courses taught at camp were distance/open water. Doctor G proposed swimmer clinic in February.
