Mark welcomed everyone to the meeting and requested that everyone introduce themselves. Motions were made for approval of the October 16, 2014 meeting minutes and outstanding reports/items from the October 16th meeting.

State of the LMSC Address:

Mark thanked the SPMS Officers, SPMS Contractors, SPMS Committee Chairs and the SPMS Committee for their participation and accomplishments during 2014.

He presented key highlights of LMSC activities over the past year which included:

-Changes to meet host procedures and activities

-LMSC name change official, new checking account opened, a record 92 expense reports processed -Updated SPMS Bylaws and Policies & Procedures

-Awards Committee received/reviewed nominations and selected recipients of SPMS Annual Awards

-Expanded relationship with USA Swimming – USMS members can set USMS records in USA-S meets

- -Registration of 99 clubs (including 13 new clubs), over 5000 members registered (an all-time high) -USMS Coaches Certification Courses Levels 1, 2, and 3 offered in 2014 and scheduled in 2015
- -Marketing of SPMS/USMS to outside events (triathlons, marathons, open water swims)
- -Planning for SPMS/USMS Officials certification/training and proactive scheduling of officials in 2015

-Open Water Series had 35 swimmers who qualified for the series by swimming at least 3 events

-Health and Fitness articles written for each SPMS newsletter

-SPMS website maintenance kept up-to-date

Mark reminded everyone that the Swimmers of the Year and the Steve Schofield and Jim Marcus Service Awards will be presented at the SPMS SCM Championships in December.

Mark thanked Trisha Commons for her longstanding service to SPMS as she has now stepped down from her previous role as SPMS Swim Meet Services Coordinator.

2015 Meet Schedule and Championship Meet Bids:

Eileen presented the proposed SPMS Swim Meet Schedule for 2015 which included the three SPMS Championship Swim Meets. Bids received for the three 2015 SPMS Championship Meets included: -SCY – Santa Barbara Masters (April 11-12, 2015)

-LCM – Mission Viejo Masters (August 14-16, 2015)

-SCM – Long Beach Grunions/City of Commerce (December 4-6, 2015).

-MSP- To approve the proposed meet schedule including the bids for the 3 Championship Swim Meets.

There was a question and discussion regarding the issues that occurred during the previous championship meet hosted by Santa Barbara Masters. In addition to the inclement weather during the event, issues included the quality of awards, use of Meet Mobile, hotel room availability and rates, and low number of swimmers in attendance.

-MSP- To reconsider the award of the 2015 SPMS SCY Championships to Santa Barbara.

There was further discussion regarding setting standards and requirements for hosting a championship meet and assigning a liaison from the SPMS Committee to SPMS championship meet hosts to offer information and support regarding responsibilities and pre-meet preparations (similar to the USMS liaisons assigned to USMS national championship meet hosts). There was also discussion regarding requesting coaches to encourage their swimmers to enter and support SPMS championship meets.

-MSP- To pull the award of the 2015 SPMS SCY Championships from Santa Barbara. The SPMS Meet Operations Committee will assign a liaison to Santa Barbara Masters to address the previous issues and evaluate current capabilities. The award for the 2015 SPMS SCY Championships will be "TBD" until a status update is received and a plan for moving forward is determined. The placeholder dates will remain on the meet calendar.
