## **Minutes**

The meeting was called to order at 8:05 pm Eastern.

- 1. The osteoporosis display board produced for Greensboro was very good. It was well received and generated discussion among the members of at least one club. Printed materials were available and were also well received. The screening services were also popular; both the skin cancer screening and the spine screening stations were busy. It was felt by several who attended that the location of the poster and the screening services was less than ideal. It was not in a highly visible area. It could be even more popular if placed in a more active area.
- 2. The National Office is working with Methodist Hospital as a sponsor for summer nationals in Omaha. Several of their physicians are interested in providing screening services. The National Office will keep this committee updated on these efforts. The osteoporosis poster should be available again.
- 3. Katherine Longwell is a trainer for the Arthritis Foundation. She could provide printed materials from them to be available for swimmers at nationals. - 5. The Coaches Committee is looking for help writing dryland workouts for the coaching section and help review dryland content of the certification materials. Katherine and Markell will help with this.
- 6. We still need to develop a list of committee goals referenced to the USMS Strategic Plan. Chair will locate past committee goals/workplans. Mary and Sally will help develop new goals.
- 7. Sally noted that the first of three papers related to the study of medications and Masters swimmers has been accepted for publication. She will send the citation when available. She and former committee member Steven Erickson are the authors.
- 8. We still need a speaker for the convention presentation in Greensboro. Topic could be the therapeutic/rehabilitative/health benefits of swimming. Jane Moore will be attending the American College of Sports Medicine Annual Meeting next week. She will look for appropriate speakers there.
- 9. Katherine is interested in developing a fitness assessment for swimmers. There is interest in this idea. Sally suggested making it a study. Katherine and Sally will work on a proposal to be discussed further.
