### **Minutes**

The meeting was called to order at .9:45 AM

- 1. LMSC Reports:
  - a. <u>Arizona</u> Currently at 1172 members. Officer elections scheduled for end of this year. Swim meets scheduled every month. Open Water Series is expanding calendar for 2017.
  - New Mexico Currently at 300 members, added two new clubs. Taos Swim Meet (high altitude) scheduled for October in conjunction with local festival events. Hosted series of swim clinics at University of New Mexico using the assistant college coaches as instructors.
  - c. <u>San Diego-Imperial</u> Membership stable. Swim Meets (5 Sanctioned/1 Recognized). La Jolla Rough Water Swim cancelled for second year.
  - d. <u>Southern Pacific</u> Membership currently 4891 and 103 clubs. Swim Meets 26. Open Water Swims 6. Contractor positions elected earlier this month – Newsletter Editor, Registrar, and Top Ten Recorder. Supporting Riverside 2017 USMS Spring Nationals preparation.
- 2. MSP To endorse the nomination of Laura Winslow for the position of Southwest Zone At-Large Director
- 3. Selection of SW Zone Championship Meets for 2017: SCY Arizona, SCM Southern Pacific.
- 4. Special Guests Patty Miller, USMS President, thanked attendees for attending convention and volunteering their time; Dawson Hughes, New USMS CEO introduced himself and said he is looking forward to meeting everyone.
- 5. Old Business:
  - a. <u>SW Zone Task Force</u> Report on task force actions regarding minimal requirements for SW Zone Championship meets task force concluded that there were no extra requirements needed; the current USMS rules and requirements are sufficient. There was discussion around the need to put the current SW Zone Championship

requirements in writing and to post a policy on the SW Zone website. Motion for the Zone Chair to revisit this with the task force and draft a set of minimal SW Zone Championship requirements by December 31, 2016.
