  - a. Reminder to update Fees 2018 National Registration Fees
    - USMS 2018 individual membership: \$43
  - USMS 2018 club & workout registration: \$43

  - b. The SSLF (Swimming Saves Lives Foundation) Board of Trustees recently approved the distribution of \$108,000 in grants to programs that will host adult learn-to-swim programs in 2018. Although this represents the highest amount ever awarded by our Foundation, the total is not enough to cover all the worthy programs that applied.

After careful review of the applications, we determined that an additional \$66,000 would have been awarded, if the funds had been available. While we continue to build long-term fundraising initiatives to match the needs of adult learn-to-swim programs around the country, you can directly impact non-swimming adults in your area in 2018.
